(iii) 由就讀的學校安排午膳。

[註：學生自備午膳不會獲提供資助]

資助原則：有關津貼將會由教育局直接發放予參加學校，由學校代合資格學生繳付有關費用。

- 注意事項：
- (i) 家長自行決定是否申請在校免費午膳計劃。
 - (ii) 合資格的學生須於 9 月 4 日前向校方提出申請，及提交學生資助「全額津貼」的證明。經校方確認後才可獲得援助。若不能提交學生資助「全額津貼」的證明，便不能成功申請是項援助。
 - (iii) 家長提交的資料只用於處理有關「在校免費午膳」的申請。

辦理手續：請參加此計劃的家長於 9 月 10 日前交回條及「2020/21 資格評估申請結果通知書」或「2020/21 資格證明書」予班主任辦理。

**2020-21 Community Care Fund Assistance Programme -
Provision of Lunch Subsidy for Needy Primary Students**

Dear Parents,

The provision of lunch subsidy will be implemented by the Community Care Fund (CCF) on a pilot basis for one academic year. Details are as follows:

Eligible Students: According to the requirements/principles set out by the CCF, Primary 1 to Primary 6 students meeting all of the following criteria can participate in the captioned programme:


- (i) receiving full grant in the 2020/21 school year under the Student Financial Assistance Schemes (SFAS);
- (ii) studying in whole-day government, aided (including special schools) or Direct Subsidy Scheme (DSS) primary schools; and
- (iii) having lunch as arranged by their attending schools.

Principles: The lunch subsidy will be disbursed by the Education Bureau (EDB) to participating schools directly. Schools are required to make the lunch charges for the eligible students.

- Points to Note:**
- (i) Parents can decide whether or not to participate.
 - (ii) For eligible students,
Please apply before 4th September with the full grant SFAS proof. All late application may defer to the second phase of the subsidy scheme which will be disbursed on December. Please also note that there is no claim for the paid lunch box fee. So please apply on time.
 - (iii) The information provided by parents is used only for the processing of the application for lunch subsidy.
 - (iv) Our school may decide whether or not to include the following disclaimer:
If required, the school may provide the lunch supplier with the name of your child but it is confined to processing matters in relation to the lunch subsidy programme.

Application procedure Parents are required to submit documentary proof on SFAS full grant status (i.e. Notification of Result for Assessment of Eligibility 2020/21 or Eligibility Certificate 2020/21) to the class teacher for application before 10 Sep 2020.
